Thank you for your mail, dated 24. February 2014 to the State Prosecutor for Serious Economic and International Crime where you request my help in your case concerning the World Psychiatric Association.

The mandate of the Danish State Prosecutor for Serious Economic and International Crime concerns the investigation of serious crimes, i.e. genocide, war crimes and crimes against humanity, committed abroad by alleged perpetrators who live or reside in Denmark or otherwise fall under Danish jurisdiction.

As it seems that the Headquarters of the said association (World Psychiatric Association) reside in Switzerland your case is not included in the mandate and I regret that I am not in a position to help in your specific case.

If you are not satisfied with this decision you can appeal to Rigsadvokaten, Frederiksholms Kanal 16, DK-1220 København K, pursuant to The Administration of Justice Act, § 99, sec. 3. The appeal should be filed within 4 weeks after having received this decision.
